Interoperability Ad Hoc Report

Ms. Valerie Maguire led an Ad Hoc to discuss component interoperability as related to comments 77, 38, 78, 42, 47, 48, and 49 against draft 2.2 of IEEE 802.3bh. The Ad Hoc met for 90 minutes on November 21st. Subsequent to the Ad Hoc meeting, it was determined that the optional MDIO electrical interface specified in clause 45 allows vendor information to be used when transferring control information between the PHY and the STA. The submitters of the comments 77, 38, 78, 42, 47, 48, and 49 were satisfied with the explanation and no further meetings of the Ad Hoc are required. Refer to:

Mr. Anslow presented an overview of a ballot comment he intends to submit against draft 3.0 of IEEE 802.3bh proposing changes to the tolerance for a valid 10GBASE-Rx work clock in Table 51-12 and the signalling speed variation for 10GBASE-SW in Table 52-9, 10GBASE LW in Table 52-13, and 10GBASE-EW in Table 52-17.

Mr. Diab appointed Mr. Anslow to Chair an Ad Hoc to discuss receiver clock tolerance with any individuals interested in further discussion.

Liaison letter to IEC

Mr. Diab reported that IEEE has an agreement in place to share Standards with IEC and that IEC 60825-1 and IEC 60825-2 are available from a password protected area of the Maintenance Task Force site for the duration of the IEEE 802.3bh draft 3.0 Sponsor ballot.

Mr. Diab indicated that draft 3.0 of IEEE 802.3bh has been appropriately marked for sharing with the IEC by the IEEE-SA staff. A straw poll was conducted and the Maintenance task group unanimously agreed not to send an informal communication related to the draft to IEC since there is nothing actionable being requested from IEC members.
