The process and timeline support proceeding to Working Group ballot out of the July plenary. Mr. Diab noted that he and Mr. Law will be meeting with IEEE-SA staff at the March 2011 meeting to finalize logistics relating to the consolidation. A Task Force informal review would be conducted during the May interim based on the current plan and pending discussions on the consolidated edition. Scope limited to:

- Checking the consolidated edition for conflicts
- Folding in the relevant maintenance requests
- Coordinating changes with .3.1 / OAM and delete GDMO
- Not a "traditional" full TF review with comment tool, etc.
