#### Revision Request #1277

The maintenance request proposes adding text for the purpose of clarifying that PDs should not turn on their DC-DC load during inrush. There is ongoing discussion between Mr. Healey and the IEEE P802.3bt Task Force chair with respect to the impact of this change and any actions relevant to the this topic that have been taken by the P802.3bt Task Force. Consideration of this revision request will be deferred and the status will remain "Received".

#### *Revision Request #1283*

The Maintenance Task Force chair discussed the request with the submitter and the expectation is that a revised request, which will most likely suggest removing the paragraph in question, will be submitted. #### Corrigenda project to implement MR1286

It was agreed to initiate a corrigenda project to implement revision request #1286, which resolves an ambiguity in the timing reference point for multilane PHYs. There is interest in expediting this clarification to support the development of time synchronization protocols that wish to utilize the facilities in Clause 90 with multi-lane PHY. The Maintenance Task Force chair, with the cooperation of the IEEE 802.3 Working Group chair, prepared a PAR for review.
