#### **New Maintenance Requests**

Chair asked if anyone wants to bring a new maintenance request forward.

- Mr. Linskey asked for clarification on how to deal with a request on Clause 64. Specifically, if we open clause 64 or make a new maintenance request?
- Mr. Law responded that it depends on the level of complexity and urgency. Options available are to do it in .3av, .3ay, or corrigenda.
- Mr. Diab noted that we could do something like on PoEP where all the experts are in .3at.
- Mr Thompson noted that we should always make a maintenance request so there is a record and it is [part of the normal maintenance process
- No maintenance requests were made

### Update on AX and AY - David Law

AX

Ready

- Recirculation closed last week
- No one physically made the meeting in April.
- Conference call conducted
- Needs a recirculation
- Instructions from PatCom need a new LOA for each in AX
  - o Any LOA submitted in .3 since 802.3ad was approved need a new LOA submitted
    - 802.3AD was approved 30 March 2000
    - PAR approval June 28, 1998
  - o Mr. Thompson asked for clarification: New LOAs only on AX or both?
  - o Mr. Law indicated that AX only
  - o If there is no response to a request for LOA then tell PatCom and then PatCom reviews and decides what to do
- Discussion on whether or not the LOA issue will hold up the approval of AX
- Discussion on why the LOA should not be assumed when a standard is split out and moved to a difference standard
- Since the LOA process is not complete and a recirc on AY is needed, then in July (hopefully) there will be two complete packages ready for submission for RevCom in September
- Discussion on what happens if IEEE-SASB does not approve AX
- Mr. Grow asked for a review of the LOA list
- Mr. Law collected and continues to collect names of volunteers to track down people to help deal with the LOA requests
- Mr. Thompson indicated that he is content with the PatCom directive
- Context of the request for a new LOA can be explained in a cover letter.
