Maintenance Request #1237

This new maintenance request was discussed and it was noted that, while the proposed change had already been implemented into IEEE 802.3TM-2012 and the hyperlink goes to IEEE-SA downloads page, the text for download is mislabeled as IEEE Std 802.3an-2006 and has an incorrect underlying file name. The proposed resolution was revised to: change the download text on the website to "IEEE Std 802.3-2012 Clause 55A Matrices" and rename the filename on the server to "matrices.zip". Mr. Diab and the WG Chair will work with staff to incorporate the proposed changes. There was no objection to accepting the revised resolution and changing the status of the Maintenance Request to "Ready for Ballot".

Maintenance Request #1238

This new maintenance request was discussed and there was no objection to accepting the suggested resolution and changing the status of the Maintenance Request to "Ready for Ballot".

Maintenance Request #1239

This new maintenance request was discussed and there was no objection to accepting the suggested resolution and changing the status of the Maintenance Request to "Ready for Ballot".

Maintenance Request #1241

This new maintenance request was discussed and, after examination, it was noted that, in addition to the error identified in the maintenance request, the word "hexadecimal" has been deleted throughout section 5 of the published document. Other instances of the deletion include Figure 73A-1, the last sentence of the

second paragraph 74A, and the heading of Table 59-12. A document search reveals 14 occurrences of the word "hexadecimal" in draft 3.2 and only 2 occurrences in the published document. The proposed resolution was revised to: Mr. Diab and the WG Chair to work with staff to identify errors as errata and request a re-print of IEEE Std 802.3-2012. There was no objection to accepting the revised resolution and changing the status of the Maintenance Request to "Ready for Ballot".

Maintenance Request #1242

This new maintenance request was discussed and there was no objection to accepting the suggested resolution and changing the status of the Maintenance Request to "Ready for Ballot". Mr. Diab will discuss the opportunity to ballot as with the Chair of IEEE P802.bj to submit this change against draft 2.1 of their balloting document.
