IEEE P802.3/D3.1 ballot results

Mr. Healey noted that the Sponsor recirculation ballot of the IEEE P802.3 (IEEE 802.3bx) Revision opened on June 16, 2015 and closed July 1, 2015 and 12 comments were received.
