P802.3/D3.2 Revision (IEEE 802.3bh)

ISO/IEC JTC/1 SC/6

The process to send 802.3 revisions to ISO/IEC JTC/1 SC/6 and receive comments was presented and discussed. The procedure for open projects is understood (i.e. comments are entered as rogue comments in our tool and comments are not binding), but we do not have a process to deal with comments received against projects that are not open. There was no objection to adopting the liaison process outlined in the agenda slides to deal with comments that are received against projects that are not open. The intent is to test the process with IEEE Std 802.3-2012 out of the March plenary meeting.
