Mr. Healey noted that the status of Maintenance Requests #1235, #1236, and #1240 has been changed from "Ready for Ballot" to "Published" as the changes are contained in IEEE Std 802.3bk-2013. Mr. Healey will submit a ballot comment against the P802.3bj Sponsor ballot based on Maintenance Request #1242.

Mr. Healey confirmed that the status "Ready for Ballot" universally applies to balloting of the next revision of IEEE Std 802.3 or Maintenance project, whichever comes first.

Mr. Healey indicated that there are five Maintenance Requests available for review at this meeting. Maintenance Requests #1247 through #1250 were received by the deadline for consideration at this meeting and Maintenance Request # 1251 was received by the deadline for consideration at the January meeting. There was no objection to discussing Maintenance Request # 1251 during the meeting, but action will be deferred to the January 2014 interim meeting.

Maintenance Request #1250

This new maintenance request was discussed. There was no objection accepting the proposed revision and changing the status of the Maintenance Request to "Ready for Ballot".

Maintenance Request #1251

This new maintenance request was discussed and there was unanimous support for the proposed revision. This Maintenance Request will be formally considered at the Maintenance meeting in January.

Mr. Healey noted that there are five "Legacy" Maintenance Requests that predate IEEE StdTM 802.3-2008 and that have had no follow-up actions taken by their comment submitters since 2007.

Legacy Maintenance Request #1107

The comment submitter agreed to withdraw this comment. The status of the Maintenance Request will be changed from "Ready for Ballot" to "Withdrawn".

Legacy Maintenance Request #1134

The comment submitter agreed to withdraw this comment. The status of the Maintenance Request will be changed from "Ready for Ballot" to "Withdrawn".

Legacy Maintenance Request #1175

This maintenance request was discussed and it was determined that the scope of this comment is beyond that of the Maintenance Task Group.

Legacy Maintenance Request #1176

This maintenance request was discussed and it was determined that the scope of this comment is beyond that of the Maintenance Task Group.
