Mr. Law gave an update in the topics being discussed at the LMSC EC.

There was discussion on the submission of documents to ISO/IEC JTC1/SC6. Mr. Law outlined a proposal for a plan going forward.

Proposal to restart submission of IEEE 802.3 to SC6

- Circulate sponsor ballot drafts to SC6 for comment
- Submit approved IEEE 802.3 standards to SC6
 - SC6 will make no changes to published IEEE Std 802.3
- Only submit revisions

Some concerns were raised with respect to document title, SC6 comments in the context of the Sponsor ballot process, formatting, and other items. It was clarified that circulating sponsor ballot drafts to SC6 for comment did not represent mandatory coordination. It was pointed out that any comments from SC6 would not be associated with a disapprove vote since SC6 would not be part of the sponsor ballot pool. It was observed that the maintenance process could be used to address any comments that fell outside of the ballot cycle as is the norm.

Mr. Law observed that there is consensus on the second and third points of the proposed plan and that discussion was on the submission of revision sponsor ballot drafts to SC6 for comment.

Mr. Law changed the first point of the plan to "Circulate sponsor ballot drafts to SC6" which he interpreted to mean that when IEEE 802.3 generated a new sponsor ballot draft for a revision, a letter would be sent to SC6 notifying them of the generation of the draft and how to access it. It was observed that this modified proposal had consensus.

There was some discussion of whether or not IEEE 802.3 CFI meetings are covered by the Tutorial waiver.

It was clarified that CFI meetings are Working Group meetings and not tutorials. It was observed that the meeting fee (including hotel and late registration penalties) was excessive for those who only wanted to attend a CFI meeting. Mr. Carlson proposed a model where a special CFI meeting (or more generally a "pre-Study Group activity") fee

would be assessed with special designation on the badge. There was some concern raised regarding the complexity of that model and whether this new designation of attendee should be allowed to vote in the straw polls. It was asked if waivers could be addressed with an exception process to be used at the chair's discretion.

Mr. Law asked if there was any objection to have a separate registration fee for attending only CFI meetings as a rate that covers costs. None responded.

Some concern was expressed regarding the need for pre-emption (versus using smaller Ethernet frames to mitigate head-of-line blocking related latency), the magnitude of the change required to IEEE 802.3, and compatibility with the architecture.

It was noted that the effective overhead resulting from the use of small frames, combined with the desire to use 100 Mb/s Ethernet, may not provide sufficient bandwidth for converged network applications.
