# 2012 July meeting (I)

- » Task Force met on Wednesday afternoon (13:00 – 18:00) and exhausted the agenda. No meeting on Thursday morning.
- » Examined three technical contributions:
  - ☐ Two contributions on market drivers and cost model for PBEx. Further study on PBEx is needed, especially for technical feasibility, implementation options and cost model.
  - ☐ One contribution on overload scenarios for different PMD and ODN configurations. No follow-up was requested.
- » Link model was presented and adopted by the TF for future use. The approved version of the spreadsheet will be posted on Tools website (to be created and announced after the meeting).
  - ☐ Spreadsheet builds on 10G-EPON link model developed by P802.3av

# 2012 July meeting (II)

- » Completed revision of 85 received comments on D1.0
  - ☐ Approved responses posted on Comments website
- » Out of these 85 comments, we have:
  - ☐ E: 23; T: 51; ER: 7; TR: 4
  - ☐ ER comments were treated as E (Task Force review)
  - ☐ TR comments were treated as T (Task Force review)
  - ☐ 69 comments were accepted / accepted in principle
  - ☐ 19 comments were rejected, mostly with requests for more information to substantiate changes.
  - ☐ Several action items were taken and will be announced on the email reflector after the meeting

Dear Ms. Liu Qian,

Following our last letter dated March 2012, we would like to update you on the status and progress of the project.

The *Extended EPON* Study Group completed its charter in March 2012 and the first meeting of the IEEE P802.3bk *Extended EPON* Task Force took place in May 2012 during the IEEE 802.3 interim meeting in Minneapolis, MN, USA. At that meeting, baseline proposals for the project were adopted. The draft D1.0 was generated and subsequently opened for Task Force review, which closed on the 9<sup>th</sup> of July 2012. We received a total of 85 comments.

During the IEEE 802.3 plenary meeting in San Diego, CA, USA in July 2012, the IEEE P802.3bk *Extended EPON* Task Force resolved all 85 received comments. The new draft D1.1 is attached to this letter for your information. This draft is open for Task Force review until the 5<sup>th</sup> of September 2012. All received comments will be processed at the following IEEE 802.3 interim meeting in Geneva, Switzerland, Sunday September 23<sup>rd</sup> through Friday, September 28<sup>th</sup>, 2012.
