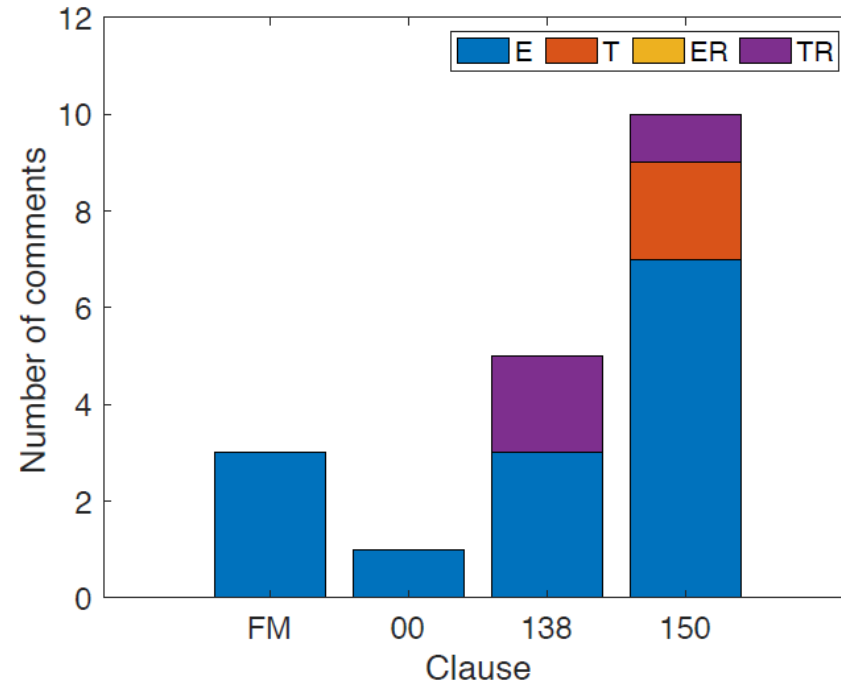
P802.3cm D2.1 Working Group Ballot

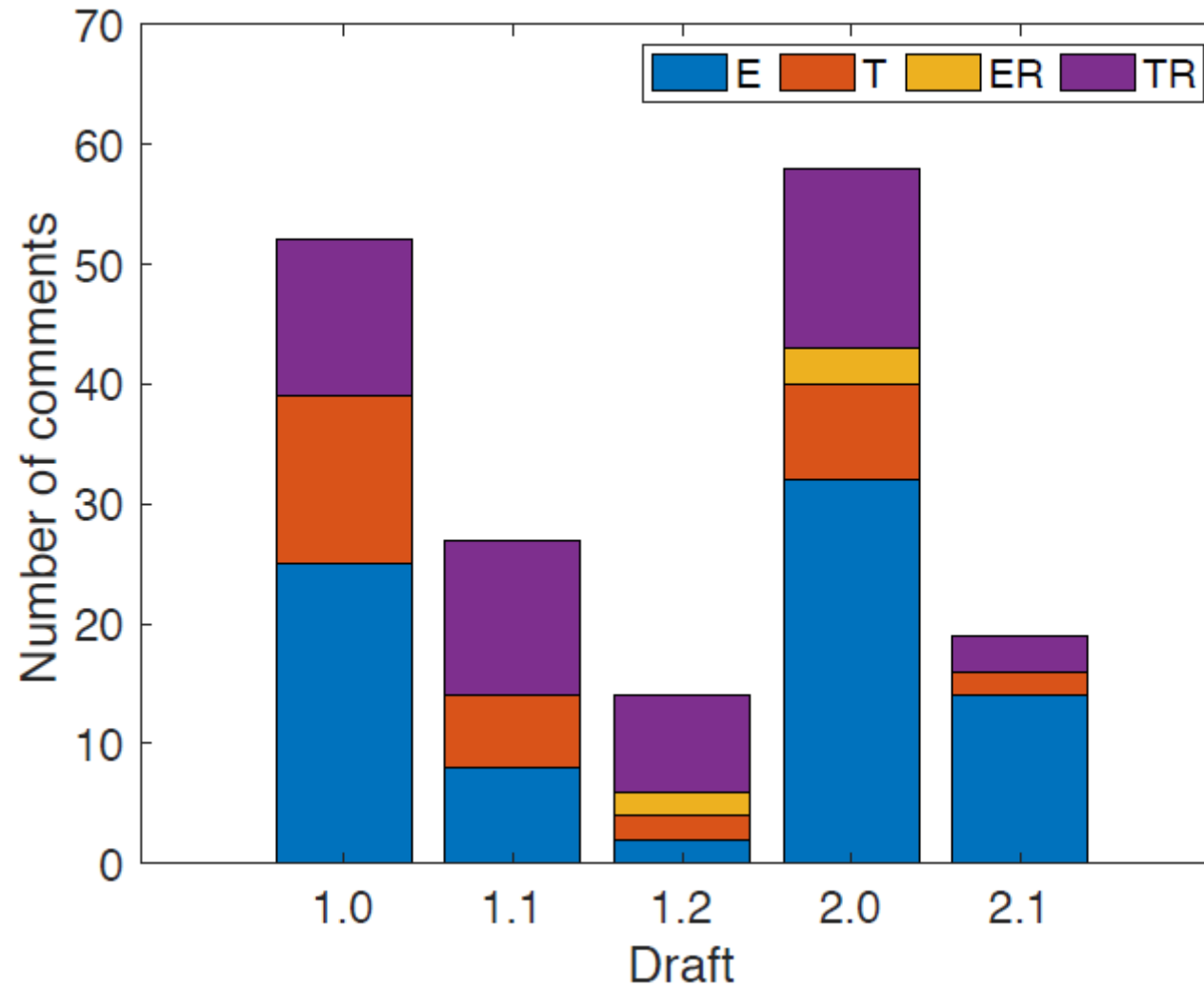
Distribution of comments against D2.1
