802.3ad Task Force Report

- 802.3ad Task Force met Wed. Nov 10 to resolve the 16 comments received in the recirculation of the Working Group ballot.
- All comments resolved.
- Resolution of technical comments regarding the Mux State Diagrams was to not change the diagrams at this time, but to include corrected diagrams in the sponsor ballot package with a cover letter explaining that the chair will submit a sponsor ballot comment to incorporate the corrections into the draft.
