IEEE 802.5 7-11October 1996 Meeting: Summary

There were 20 full and part time attendees at this meeting. Work items addressed included

- All comments against 802.5r Draft 5 were successfully resolved
 - Approval was given to circulate Draft 6 for Confirmation Ballot
- Resolution of comments against 802.5j Draft 4
 - Approval was given to develop Draft 5 (draft 4 with Change Bars removed) for LMSC Ballot
- Because of the absence of the editor, there was no action taken on 802.5s.

In addition to ballot resolution

- Approval was given to submit *proposed* High Speed Token Ring PAR to the Executive Committee
 for review, so that 802.5 would have the freedom to choose to submit or not submit a PAR at the
 November meeting.
- A High Speed Study Group Task Force met on Friday to develop the appropriate wording consistent with the input provided earlier in the week.
