Add underscoring of FPTI as described in the Solution and in Figure M.3 ref TEDb. Also, on page 6 (PDF page 10), line 43, add new numbered item in the Change Description:

"10) Change FPIT to FPTI in transition ref 1210 (TEDb) and in the corresponding transition in Figure M.3."

**Solution:** Move the definition for FPTI to before FPTXC, or mark it for movement in the next errata. Change the text starting at line 40 to match lines 35-36, that is, 'Insert ...following the definition of FPSLD...

**Response:** Modify the editing instruction for the insertion of FPTAS to include the phrase "and reorder the definitions alphabetically".
