6.2 Executive Session additions

The matters discussed in Executive Session are confidential, and therefore, attendance at the Executive Session shall be limited to the officers of the Working Group, officers of the Standards Committee, officers of the technical group that established the Standards Committee, members of the IEEE SASB or IEEE SA Board of Governors unless they have a conflict of interest with respect to a matter to be discussed in Executive Session, in which case they may not attend until discussion of the matter is concluded; outside advisors (e.g., lawyers or consultants) where necessary to provide professional guidance, and select IEEE SA staff who may have information or a perspective relevant to the subject matter discussed in Executive Session. Persons who are determined to have a conflict of interest and other individuals may be invited to the Executive Session to provide pertinent information and then excused prior to any discussions or decisions. In each case, except as authorized by the Working Group, participants in an Executive Session are prohibited from discussing or disclosing any information presented and discussed during such Executive Session to a third party or other person not present during the Executive Session, and shall not continue to discuss such matters after the Executive Session has adjourned.

6.2 Executive Session additions (cont.)

Executive Sessions should be conducted face-to-face (in person) to provide the greatest assurance that the content of such Executive Sessions will be kept confidential. However, when necessary, Executive Sessions may include participants who participate by teleconference provided such persons agree not to disclose any information so discussed, and agree that they will participate in such conference in a manner that does not result in third parties gaining access to such discussions or information.

6.3 Meeting Session Fees

The Working Group, or meeting host, may charge a meetingsession fee to cover services needed for the conduct of the meetingsession. The fee shall not be used to restrict participation by any interested parties.

The Working Group Officers shall set the meetingsession fees in consultation with those planning a particular meeting.

Everyone who attends a meeting, except for those for whom the fee has been waived, shall pay the meeting fee.

For plenary sessions, the Standards Committee determines which individuals will have the meeting fee waived. For interim sessions, the Executive Committee of the Working Group or the Joint Executive Committee of the Working Groups responsible for the session determine the individuals for which the meeting fee will be waived.

The Working Group Chair may conduct votes between meetings by the use of a letter or electronic ballot. If such actions are to be taken, they shall follow the rules of IEEE Bylaw I-300.4(5) [IEEE Bylaw I-300.4(5) (paragraph 2).

For Working Groups within the IEEE Standards Association, unless a more restrictive requirement is specified in the governing documents of the Working Group, majority consent of those participating, provided a majority of the voting members of the Working Group respond, shall be required to approve an action taken without a meeting. The action and written confirmations shall be filed with the minutes of the Working Group.

Formal inquiries All external requests for information relating to the Working Group should be directed to the Chair and recorded by the Secretary. All replies to such inquiries shall be made through the Chair, unless otherwise specified by IEEE SA. These communications shall make it clear that they are responses from the Working Group. Communications shall be in compliance with the Sponsor's Standards Committee's communication requirements.

14. Directed Position (1)

- •Members of the Standards Committee have a responsibility to act in the best interest of the Standards Committee as a whole. Working Group Chairs have a responsibility to represent their Working Groups on the Standards Committee. At times these responsibilities are in conflict with each other.
- •Decisions of a Working Group may be of such a nature that the Working Group members deem it necessary to "direct" the Working Group Chair to vote a specific way on Standards Committee motions related to a Working Group decision. When directed, through the process described below, the Working Group Chair shall vote as mandated by the Working Group resolution for the specified subject on any formal vote(s) in the Standards Committee. It would be anticipated that the use of a directed (i.e., instructed) vote is an exceptional situation and hence used infrequently, e.g., critical PAR votes, formation of new Working Groups and PAR Study Groups.

14. Directed Position (2)

- •Working Group developed positions are not to be considered as automatic Directed Positions. After a Working Group motion has been passed that establishes the Working Group's position, a separate Directed Position motion (three-quarters approval required, as defined in 6.1) is required to make that Working Group position a Directed Position. A Directed Position motion applies only to a specific, bounded, Working Group issue that is to be brought before the Standards Committee. Directed Position motions may not be combined, nor may any procedure be adopted that diminishes the extraordinary nature of establishing a Directed Position.
- •The Working Group Chair, however, has the freedom to express other views in an attempt to persuade members of the Standards Committee to consider them, however, such views shall be identified as distinct from and not the formal Working Group Directed Position. The Working Group Chair is required to disclose to the Working Group Chair's intent to offer a position contrary to a Directed Position. When presenting a Directed Position to the Standards Committee, the Working Group Chair is obligated to present and support the Working Group's Directed Position motion with voting results, along with pros and cons behind the motion.

4.2 Attendance at Meetings

Working Group membership is by individual. Those attending <u>meetingssessions</u> shall pay any required <u>meetingsession</u> fees if established. Participants seeking Working Group membership are responsible for fulfilling the requirements to gain and maintain membership.

All persons that achieve session attendance creditCredited Attendance for at least 75% of the meeting slots for the initial session of a Working Group become members of the Working Group. Thereafter, membership in a Working Group is established by achieving session attendance creditCredited Attendance in at least 75% of the meeting slots at the sessions of the Working Group for two out of the last four plenary sessions; one duly constituted credited recent interim Working Group or Task Group session may be substituted for one of the two plenary sessions required to establish membership. A recent interim is any of the interims after the first of the four most recent plenaries. A duly constituted credited interim session (an interim session with attendance credit) is a one that has been declared by the Working Group Chair to be an interim Workingor Technical Advisory Group or Task Group sessionChair.

Membership may be declared at the discretion of the Working Group Chair (e.g., for contributors by correspondence or other significant contributions to the Working Group). The Working Group Chair may authorize meeting attendance creditCredited Attendance for individuals while on activities approved by the Working Group Chair.

4.2.1 Requirements to Maintain Voting Membership

A home groupHome Group is a Working Group or TAG in which a person is a member (i.e., has voting rights). A target group Target Group is a Working Group or TAG in which the person is attending and the Working Group Chair of the home groupHome Group has approved as target group Target Group. Maintaining credit is meeting participation creditCredited Attendance that is registered in the home groupHome Group while the person is attending a meeting in the target group Target Group.

A voting member's obligation to respond to Working Group letter ballots (in which they are eligible to vote) is in addition to their obligation to attend Working Group <u>meetingssessions</u>.

A Letter Ballot Series is the initial ballot plus any recirculation letter ballots on that question.

A voting member that fails to return 2 of the last 3 Working Group letter ballots, excepting recirculation letter ballots, ballot series in which they are eligible to vote becomes a non-voting member. lose membership. Their previous session attendance credit Session Attendance Credits do not count towards regaining voting membership.

If a Working Group letter ballot closes within 14 days of prior to a meetingsession, any changes to voting membership resulting from the ballot shall be delayed until after the meetingend of that session.
